

## Entry into Denmark - Information valid as of Thursday July 29th.

Even though “test after entry” is not required for all, we strongly recommend that all participants take a test at the airport immediately after arrival. It is free of charge.

### **Travelling and fully vaccinated:**

#### **Travel restrictions for people who are fully vaccinated\***

Travel restrictions for people who have been fully vaccinated with an EMA-approved vaccine and who are Danish citizens or are from an EU or Schengen country, Andorra, San Marino, Monaco, the Vatican City, an OECD member state or a yellow third country.

\* Includes only persons who have been vaccinated with an EMA-approved vaccine and are residents in EU and Schengen countries, OECD countries or "yellow" third countries, and Danish citizens who have been vaccinated abroad.

\*\* Applies only to fully vaccinated from OECD countries and "yellow" third countries. Vaccinated persons from non-OECD countries must have a worthy purpose and be able to present a negative test, which has been performed no more than 48 (antigen) or 72 (PCR) hours prior to the time of entry, in order to be allowed entry into Denmark.

In Denmark, you are considered to be fully vaccinated once you have been vaccinated with a vaccine approved by the European Medicines Agency (EMA), and at least two weeks have elapsed since you completed your course of vaccination.

It is also a requirement that you are able to document this through the presentation of a valid EU Digital COVID Certificate, or by documenting that your permanent residence is in an EU or

Schengen country, or in Andorra, San Marino, Monaco, the Vatican City, an OECD member state (including Greenland and the Faroe Islands) or in a yellow third country.

You must be able to present relevant documentation that you have been vaccinated. If you have the EU digital covid certificate for vaccination, you can show that. If not, you should check if your vaccine certificate contains the following information:

- Name
- Date of birth
- Vaccine name
- Effective date - time for 1st and 2nd vaccination (for a vaccines where 2nd dose is required)

### **Travelling on a negative test:**

#### **Travel restrictions for people who are not vaccinated and who have not previously been infected with COVID-19**

#### **Test requirements campus/bars/restaurants:**

To enter University campus and to be seated inside in bars and restaurants, you must be able to document that you are fully vaccinated – see above when you are considered fully vaccinated in Denmark.

If you are not fully vaccinated, you must be able to present a negative PCR test no older than 96 hours or a negative rapid (antigen) test no older than 72 hours.

### **How to get tested:**

Testing is free of charge. If you don't have proof that you are fully vaccinated, you must test every 4 (PCR) or 3 (Antigen) days.

To obtain the PCR test result, you must register on [covidresults.dk](https://covidresults.dk): Covidresults.dk offers PCR test for COVID-19 for non-Danish citizens. As a non-Danish citizen, you have to register on Covidresults.dk before meeting up at the test centre. To create an account choose "Sign up" and then enter your email.

The easiest is to go to the rapid test center in Fælledparken, right behind the Niels Bohr Institute (large white tent), open 8:00-20:00 Mon-Sun, no booking required. Results can be provided by text message for rapid (antigen) tests. Or, you can wait at the test centre for 15 and 30 minutes for your results.

### **Guidelines in case of symptoms or a positive test:**

In case of symptoms or a positive test, self-isolation is required, which means that the person in question must stay in the hotel room. Two negative tests are required before the isolation can be lifted, on day 4 and day 6. This must be a PCR test, not a rapid test.

### **Bus / metro in Copenhagen:**

#### **Face masks:**

If you travel by bus, train or metro, you must wear a face mask or face shield. You are required by law to wear a face mask or shield covering both mouth and nose when entering or exiting the train and when standing inside the train. When seated in the train, you are allowed to remove the face mask/shield.

#### **Tickets:**

The easiest is to buy a Citypass which gives you access to bus/train/metro. A citypass small is sufficient (300 Danish Kroner for 120 hours/5 days) and can either be bought at the airport (machines near the entrance) or online: <https://dinoffentligetransport.dk/citypass>

Otherwise paper tickets can be bought at the metro stations (typically there are machines on the floor above the rails) using a card or coins (but not bills) or in any 7-eleven (<https://www.7-eleven.dk/find-butik/>). Please note that it is not possible to buy tickets directly in the bus.

It is also possible to buy online tickets if you download the app 'DOT Tickets'.

If you don't have a valid ticket or pass when entering bus/train/metro you risk a fine of 750 DKK.
